**Entries:**

Entries will be accepted as received. **Your entry must be complete with BHA number and signed with liability waiver initialed or they will not be accepted.** Registration number & Barn Hunt Regulations may be obtained on the website: www.barnhunt.com. No more than ten (10) entries per envelope. No entries will be accepted by phone or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$50 collection fee to the amount of each returned check. **LATE ENTRIES: ADD \$5.00 PER CLASS.**

**Refunds:**

Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other causes beyond the control of the organizing committee. Refund for dog or handler injuries after close of trial may be refunded with a doctor's/vet's note required.

**Awards:**

Placement Ribbons will be awarded for 1st through 4th place in all regular classes (not Instinct) in each height division. Brown qualifying ribbons will be awarded for all qualifiers in the regular classes (not Instinct). New Title Rosettes will be awarded to those who qualify, including Instinct. High in Class Rosettes will also be awarded.

**Bitch In Season:**

Bitches in season (BIS) MAY compete at Barn Hunt trials. They will run at the end of each class. BIS must wear pants/britches at all times when not being pottied, including on the course. Owners of BIS should crate/confine their dogs away from traffic and other dogs, should post "bitch in season" signs on their crate/in their area, and potty the dog away from other competitors. **Failure to notify the Trial Sec, Club and fellow competitors of a BIS results in a disqualification and dismissal from show grounds.** Entry fees for bitches that come into season and withdraw from the trial will be refunded, less \$5.00 admin fee.

**No Flexi-Leads, e-collars or smoking is permitted on trial grounds. Dogs are not permitted to run free on property.**
