ENTRY INFORMATION

Entries will be accepted as received. No entries will be accepted by phone or fax.

Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Carole Schultz 1060 N. Bee St., DeLand, FL 32720

Returned checks do not constitute a valid entry and the Match Secretary will add a \$50 collection fee to the amount of each returned check.

Entries must be submitted using the most current official UKC entry form. A copy is at the end of this premium.

In the Nosework Trials section of the entry form, enter the appropriate Match Section, "A" or "B"; **you must enter B if you teach nosework OR if you've earned a title at the level in which you're entered, in another venue.** You may enter "A" if you are new to this level and do not teach.

Be sure to enter the "SEARCH CUE" (your start command or action) and the "ALERT BEHAVIOR" (dog's indication of a hide) on the entry form.

Dare2Train reserves the right to return incomplete, incorrectly filled out, illegible or unsigned entries.

MATCH INFO

Match will be conducted according to the rules of the UNITED KENNEL CLUB. **Dogs must be kept on leash. NO Smoking is permitted on the trial grounds.**

There will be no food service at this event. No indoor crating. There is shaded vehicle parking and we also recommend bringing shade cloth.

Exhibitors are required to clean up after their own dogs. Violations should be reported to the Event Committee. Event Committee may ask the person in violation to leave the event grounds. No refund will be made if exhibitors are asked to leave the grounds.

All exhibitors are responsible for maintaining the safety of their dog around other dogs.

COLLARS & HARNESSSES

The dog may wear flat collars, limited slip, martingale-type collars, and harnesses. Studded, "pinch" or "prong" collars, are prohibited in the nosework working area. **Electronic training collars (E-Collars) are not allowed on the show grounds.** Collar tags that are not attached or riveted directly to the collar, or any items hanging from the collar are prohibited in the nosework working area.

REFUNDS

Entry fee shall not be refunded in the event that a dog is absent, disqualified, excused or the trial is cancelled because of storms, hurricanes or conditions injurious to exhibitors or spectators. No refund of pre-entry will be made for entries cancelled after the Closing Date of October 30, 2017. Females in Season may be excused with a note from their veterinarian.

SUBSTITUTIONS

If an entered dog must be excused, due to female in season or medical or other issue as noted in the UKC Nosework Rule Book, the exhibitor may enter another dog registered with UKC to themselves or an immediate family member. Exhibitor must complete both a UKC Nosework Entry Form for the new dog plus a Class Change/Entry Correction Form, available from the UKC website or Match Secretary, at least 30 minutes prior to the start of the match. If the entered handler cannot participate in the match, another person may handle the entered dog.

AWARDS

Ribbons will be awarded for each Passing Search, including Pre-Trial. Ribbons will be awarded for 1st through 4th placement on Element Searches. Ribbons will be awarded for High in Match.

1. Nosework trials will include a pre-trial for the levels being run. Dogs need to pass the pre-trial for the level they are competing in. Dogs may be entered prior to passing, but must pass the pre-trial prior to competing that day. If the dog has passed on ORT in the applicable odor please submit a copy of proof. **Not required for Match.**
2. Individual element classes are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
3. Full Nosework Trials are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. These trials contain all four elements. Each element passed earns a leg toward a title in that element.
4. Handler Discrimination. One glove will be used and must be provided by the handler.
5. All entries must be submitted on the current “Official UKC® Nosework Trial Entry Form”.
6. Use a separate entry form for each dog entered in a club's event.
7. Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/Limited Privilege number/Permanent Registration/Temporary Listing.
8. We want you to keep the points earned at UKC Licensed events. Important things to remember:
 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
 - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
 - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.

WAIVER

All events are held under the Official Rules and Regulations of the United Kennel Club. Absolutely no alcoholic beverages, illegal drugs or firearms will be allowed on the grounds or in the buildings on the day of a UKC Licensed event.
